\* Impact of inventory reversal

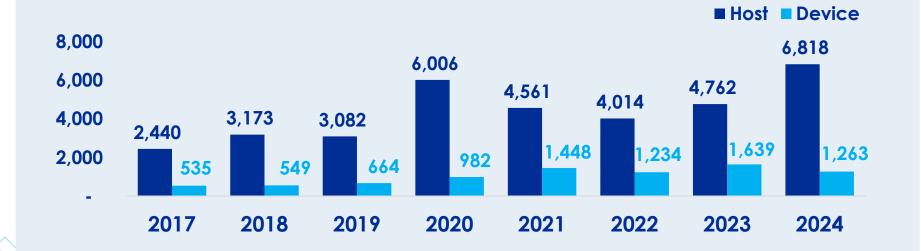

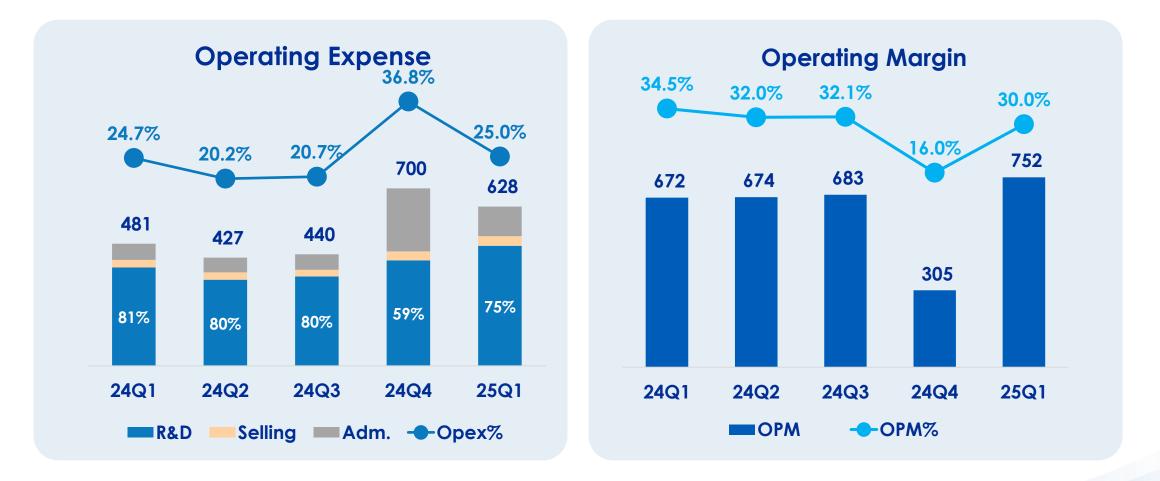

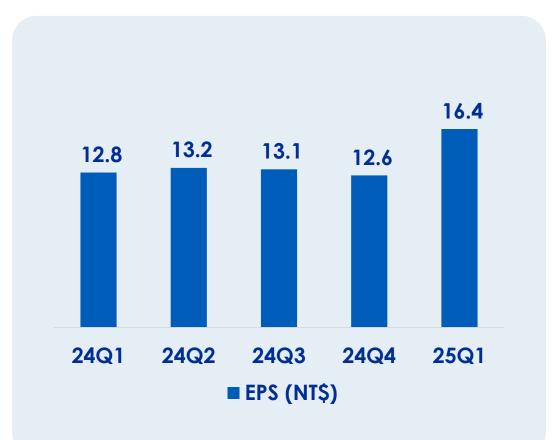
# Operating Expense & Operating Margin

(NTD: millions)



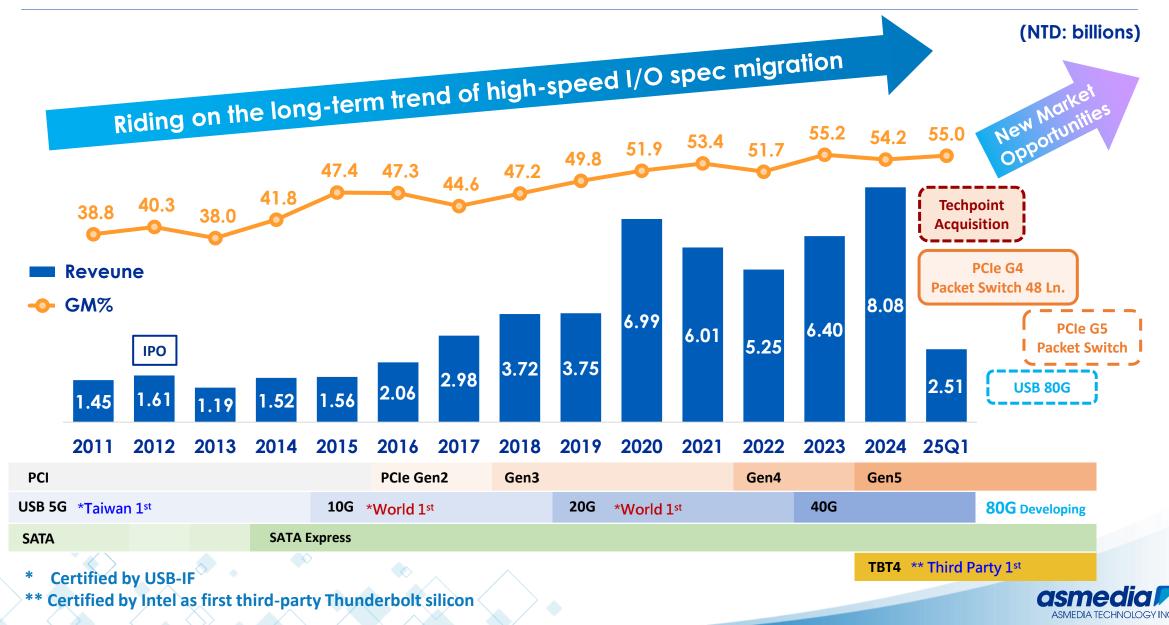
